## **Terms & Condidtions**

## 1. Company details

- 2. Scope of business
- a. Teacher Development Courses is a brand of Context Language Solutions Ltd.
- b. We deal mainly with teacher development courses and other teacher training related services
- c. We do not provide teacher training courses but are responsible for making bookings with teacher training institutions in the UK. We have legal right to represent all institutions listed on our website.
- d. We offer help with choosing the right course/s
- e. We can provide discounts on course fees and/or whole packages including accommodation
- f. We are responsible for payments made through our website made in GBP and EUR. Credit card payments are subject to a 2% fee unless otherwise stated.
- g. We provide Terms & Conditions of every teacher training institution before the booking is made
- 3. Booking
- a. By placing a booking on our website, you grant us permission to book the course with a teacher training institution of your choice on your behalf
- b. Submitting the booking does not mean your booking is confirmed.
- c. Your booking can be confirmed when full fees or deposit are paid (subject to Terms & Conditions of the teacher training institution you book your course with) and we receive confirmation from the course provider.
- d. We reserve the right to cancel any unconfirmed bookings at any time.
- e. Promotional offers are only valid if paid in full at the time of booking.
- f. If, for any reason, the course you have chosen is not available for booking we will immediately refund all fees or offer a similar course.
- g. We do not take responsibility for changes to your course or cancellations made by the teacher training institution. However, if your course is cancelled we will assist you in receiving a full refund from the course provider.

- 4. Payment of fees

- 5. Cancellations and refunds
